Eligibility: Following the procedures to enter and construct a project for the CFISD Livestock Show does not guarantee eligibility to participate in the show or sale. As noted in the rules and regulations, the exhibitor understands that they must be eligible to compete at the livestock show based on UIL and Cypress-Fairbanks ISD guidelines. Ineligibility to compete may result from failing grades and/or placement at an alternative learning campus. In addition, students must be enrolled in an agri-science class at least one semester of the current school year, paid FFA members, and owe no fees or fines to the local FFA chapter. In the event the exhibitor is ineligible to compete, said animal will not be allowed on the show grounds to participate in the show or sale and project-related expenses are non-refundable.

#### **Purpose of Form**

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following:

- Form 1099-INT (interest earned or paid)
- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)

- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding? on page 2.

By signing the filled-out form, you:
